In addition to the chart above, we may use, disclose, or share your information:

- To evaluate or conduct a merger, divesture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of our assets, whether as a going concern or as a part of bankruptcy, liquidation, or similar proceeding, in which personal information held by us is among the assets transferred.

We will not collect additional categories of or use the personal information we collected for materially different, unrelated, or incompatible purposes without providing you notice. We do not use or disclose sensitive personal information for purposes other than those specified in the law or regulations.

We do not "sell" Personal Information, including Sensitive Personal Information, and we do not "share" Personal Information, including Sensitive Personal Information, for purposes of cross-context behavioral advertising, as defined under the TDPSA. We have not engaged in such activities in the preceding 12 months.

II. Your Rights in Your Personal Data

Texas residents have certain rights in their data, including:

- (A) Right to know what personal information we have collected about you, including the categories of personal information, the categories of sources from which the personal information is collected, the business or commercial purpose for collecting, selling, or sharing personal information, the categories of third parties to whom the business discloses personal information, and the specific pieces of personal information we have collected about you.
- (B) **Right to delete** personal information we have collected from you, subject to certain exceptions.
- (C) **Right to correct** inaccurate personal information we maintain about you.
- (D) If we sell or share personal information (which Kean Miller does not), the **right to opt-out of the sale or sharing** (information for cross-context behavioral advertising purposes) of their personal information by us.
- (E) If we use or disclose sensitive personal information for reasons other than those set forth in the law or regulations (which Kean Miller does not), the **right to limit the use or disclosure of sensitive personal information** by us.
- (F) **Right to opt-out of targeted advertising or profiling** in furtherance of a decision that produces a legal or other significant effect on the consumer.

• (G) The right to not receive discriminatory treatment by us for exercise of privacy rights conferred by the TDPSA.

If you opt to exercise your privacy rights, we are required to first verify your identity. This may require us to ask you certain questions to confirm your identity or require you to provide state-issued identification. If you make a deletion request, we may ask you to verify your request before deleting your personal information.

IV. Texas Limitations
